You need to be circumspect in what you say at school. FCFT is the place to turn for advice. All of the people you will talk to here at the FCFT office are trained in Labor-Relations issues. They know FCPS regulations and School Law well. What you tell them will remain confidential. Nothing will be revealed without your approval to do so. You can count on them to give you timely and accurate advice. We urge you to do what they suggest to protect

your self and your job. You have civil rights and your rights as an employee. Our staff understands these rights and will work in your best interests. FCFT is just a phone call away. Don't just dwell upon a school situation, call FCFT for counsel.

RESPOND TO THE PRINCIPALS' SURVEY

You should have received the Principals' Survey form at your home address. Please respond honestly and write as many comments as you like. FCFT wants to know who are the best Fairfax County Public School Principals. All of your comments are strictly confidential and will be seen by the FCFT staff only. Your comments are also anonymous. If you don't respond, your principal may not be recognized for outstanding work. When the votes are tallied, FCFT will reward the winners with certificates, notify the School System, and publish the winning names.

FCFT advises our members to keep twenty days of sick leave in their accounts, just in case something happens for which short-term disability (STD) would be needed. Before short-term disability begins, there is a twenty-day elimination-period. This means, days one through twenty will be your sick

leave days. Day twenty-one will begin short-term disability.

If an employee does not have twenty days of sick leave, those days will become leave without pay.
