### **BUDGET UPDATE**

Superintendent Garza released the Proposed FY 2015 Budget to the FCPS School Board on January 9. The Budget of \$2.5 billion is a net increase of \$98 million from the FY 2014 Approved Budget. The increase in the budget is due to annual growth in student enrollment, an increase in health insurance rates, and an increase in the required contributions to the Virginia Retirement System. Student enrollment continues to grow at a rapid rate with 15,603 more students enrolling since 2010. The school division also developed a menu of potential cuts that will require many reductions in school system positions. Nearly every department will be affected. The coming months will bring many public hearings with the community, the School Board, and the Board of Supervisors to inform everyone about the budget and needs of the school system. Final decisions will be made in late May.

### **EVALUATION UPDATE**

January is also the time for the Mid-Year Performance Assessment. If you receive a 'Needs Improvement' or 'Ineffective', call the FCFT office at 703-451-6840 immediately for assistance. An FCFT Labor-Relations Specialist will help you. Remember that your call is confidential, but we need to know your name in order to verify membership to ensure that you are eligible to draw upon your FCFT benefits.
