FY 2016 BUDGET RELEASED

On January 8, 2015, Superintendent Garza released the FY 2016 Proposed Budget of \$2.6 billion. This is an increase of \$64 million from the FY 2015 Approved Budget. Many issues are driving the requested increase in the budget from last year. The Superintendent is very concerned about being able to offer compensation increases for employees, and cited the fact that many teachers have left for nearby school systems that offer higher salaries than FCPS. FCPS' enrollment continues to grow yearly with changing student demographics. Projections are that student enrollment growth could cost an estimated \$20 million dollars annually.

In the next few months the School Board will hold many public hearings about the budget along with the Fairfax County Board of Supervisors. Community members and other interested parties can all testify with their ideas. The final approved budget will occur on May 21, 2015.

STEM ESSAY CONTEST

Governor McAuliffe and the Virginia Council on Women have announced the 4th annual STEM (Science, Technology, Engineering, and Math) Essay Contest for high school junior and senior girls. The Council will award one \$5,000 scholarship to a female junior or senior who will be pursuing a STEM career at an institution of higher education. To be eligible, one must be a female who resides in Virginia and holds at least a 2.5 GPA. Applications and guidelines are available online at : STEM Essay Contest. Entries must be submitted by February 25.

A REMINDER WHEN DRIVING

According to a national poll sponsored by the National Safety Commission, 71 percent of Americans have not heard of "Move Over" laws. Forty-nine states have "Move Over" laws. The laws are aimed at protecting emergency responders working along the roadside. Fairfax police report that many local residents are not observing the law. They are asking everyone to become aware of the law and obey it. The law is in the news again since an emergency responder was hit and killed on the VA Beltway in early January. The law requires that drivers, upon noticing an emergency vehicle or police car with flashing lights on the side of the road, move their vehicle by one lane. If that is not possible, drivers must reduce their speed and pass with due regard for safety. A violation of this law is a Class 1 misdemeanor and additional penalties will be imposed if a crash occurs. The issue is a very serious one. The National Law Enforcement Officers Memorial Fund reports that since 1999, 164 police officers have been killed after being struck by vehicles along America's highways.
