## **CALL FCFT FIRST!**

We hope that things are going well for you and that you are feeling positive about your classroom situation. Unfortunately, anything can happen when you are dealing with students. Accidents do occur unexpectedly. You need to document anything that happens which could affect you negatively. Write down all information about any incidents that occur with students. Do so while the incident is fresh in your mind. Be particularly careful with unruly students. Stay calm.

**If you think that you are going to be investigated, call us first**. Don't say anything that may incriminate you, when you think that you may be disciplined. Don't talk with other teachers. Be circumspect in what you say to anyone.

In meetings with FCPS administrators, ask to have your union representative with you. In meetings with CPS and/or law enforcement, ask to contact your union and an attorney.

Do not meet with CPS or law enforcement and FCPS officials, simultaneously, without legal representation. Contact FCFT, ASAP.

#### **NEW TRAFFIC LAWS**

The Virginia Department of Motor Vehicles (DMV) issued some new rules of the road. We are seeing more bicycle lanes on our roadways now, so you should know that bicycles, mopeds, and other non-motorized vehicles are now included in the list of vehicles for which a motorist can be cited for following too closely. Motorists may cross double yellow lines to pass a bicyclist, pedestrian, or skateboarder, if such movement can be made safely. Drivers who pass a trash or recycling truck on a neighborhood or two-lane road must decrease their speed to 10 mph below the speed limit and pass at least two feet to he left of the truck. Drivers passing a stationary mail vehicle displaying a flashing, blinking or alternating amber light must proceed with due caution and maintain a safe speed for road conditions.
